- d) Basic pay + grade based salary and other allowances etc. of government employees to school staff through account pay cheques/online transfer.
 - e) Cooperate with the officials of the Education Department during the inspection of the school. In case of non-cooperation, the penalty provisions laid down in paragraph no. 8 of the instructions issued by the School Department dated 26-1-2018 will be applicable.
 - f) In the light of the order dated 17-08-2022 passed by the Hon'ble High Court in Writ Petition No. 1796 of 2022 and the decision to be pronounced in the future, it will be effective from the date of receipt of No Objection Certificate by the school.
3. In case of violation of the above mentioned conditions, the No Objection Certificate will be cancelled.

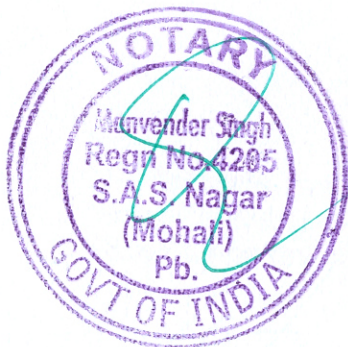

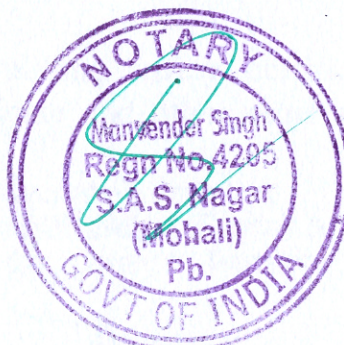
